## Disaster Case Management Training: Basic

Basic Disaster Case Management Training is a two-day (14 hours), in-depth course designed to prepare caring helpers for their work in guiding survivors through their recovery. UMCOR’s model for disaster case management uses a (w)holistic approach, which incorporates the unique perspective of the faith community with an understanding of the emotional, spiritual, and physical impact of the disaster on survivors.

*Who should attend:* All persons who wish to serve as disaster case managers and their supervisors.

*Description:* The course teaches participants how to identify and address unmet recovery needs of all survivors, particularly people who were vulnerable before a disaster.
