WHO CAN WE BE TOGETHER?

"BUILDING COMMUNITIES OF HOPE AND JOY"

In July I experienced building communities of hope and joy through two events.

First, our conference summer executive committee gathered in person at Selah for a productive business meeting, wonderful meals provided by Selah United Women in Faith, and conversation. We had many special moments including the following two:

 The daughter of Elizabeth Williams brought her to present her report. We celebrated the adoption of her petition at the PNW Annual Conference in June. This is consistent with our climate justice priority and encourages individuals and congregations to divest from the fossil fuel industry, reduce broad-spectrum herbicides to encourage native flowering plants and bolster

- pollinators such as bees and butterflies, and avoid Styrofoam and single-use plastics.
- 2) Fran Houser is responsible for Love Ribbons and we voted to appoint her to the board. She sold these successfully at Mission u.

Second, after our meeting, we went to Wesley UMC for Mission u 2022. The theme was "Who Can We Be Together?" This started with an unexpected challenge when Marilyn and Dennis Reid took our beloved dean Carol Mariano to the hospital with severe stomach pain.

Thankfully, she was able to check out Sunday afternoon. Terry Raymond drove her home in her car with Sue Raymond following them. At the church five of us

Carol had an excellent script that allowed Marilyn Reid to lead Mission u. The three-day event included plenaries, worship, mission presentations, and even a healing service. Sue Raymond, our Crest to Coast leader, presented an outstanding bent-over woman monologue.

Eight classes on Luke 13 focused on how Jesus responded to social oppression. Each included Bible study, discussion about creating spaces of care, and personal reflection. One session focused on welcoming LGBTQ as leaders in our churches.

On Sunday we worshiped with the Wesley UMC congregation. Pastor Shane Moore preached on "Healing and Restoration in God's Beloved Community." He wished that he could be like Jesus and always stand up to difficult challenges. He cited the eight-woman who gathered in March 1869 as an example. They made a difference by sending women missionaries to provide health care and education in India.

Sharen Delgado from California tuning in and breakout room speakers continuing the conversation regarding climate justice, water issues, creation justice, and community gardening.

If you have read the "featured" book report, you will notice that I wrote it. I think having watched Deaconess Cindy Johnson's video about her calling in the Brownville, TX area where she lives and works, spurred my campaign for us to send warm blankets to those who had nothing more than a piece of blue tarp to cover themselves where they slept on the ground. I am sure we sent several hundred, for which I am very grateful. Then, Cindy told me about the "La Posada Project". This would be something that would be a blessing to many, over many years, different that a blanket, a gift card, or a meal. I put it out there to all the districts, asking each to contribute \$1000. Five districts, at least 10 units per district, 10 women per unit, or more = \$10.00/per member. Well, it didn't quite work out that way but as

of this writing, we are close to making our goal! If you would like to donate, connect with me (Hay 77@hotmail.com) and I will tell you how to make out the check and where to send it. I can't thank you enough, and certainly, Cindy is extremely grateful. As of this writing, we are the only conference that has responded. I am proud to be a member of the Pacific NW Conference United Women in Faith.

SHOWER MINISTRY IN ANCHORAGE ALASKA



In 2020 I was attending Alaska Pacific University. Part of the curriculum is to present a senior project to show what you have learned and what you are planning. My passion project was centered around the stigma of homelessness. I wanted to find a platform where the individual who was experiencing homelessness would be humanized. Where someone would be seen as a person, not just a homeless person, but an individual. At first, the thought was to interview people on camera and have them tell their story, any story they want. No script, questions, just a chance to tell what they wanted to tell. But then I realized what I was doing was just taking something and not doing anything in return. I started watching videos trying to find something out of the box that could be a part of this idea.

In California, there is a company that transforms public transportation buses into mobile showers. They work with the city to use city water; they also offer to help set these up in other states. They will help with planning and implementation. After seeing this I was excited! I started researching it and talking to anyone who would listen to me talk about showers. One day a friend said, "It's too bad you can't use the disaster relief shower trailer that the conference owns to do this." I had been going at this for months and had not even once thought about using the shower trailer, so I emailed the pastor of the church where the trailer was housed and we started a conversation on what it would look like to use the trailer and how we could be in mission together. But of course, there was not any funding to be able to launch the showers. But I

was determined to make this happen. I realized I don't own a vehicle that can tow the trailer, but my brother does. He graciously let me borrow it! So, the first day, we pulled the trailer 45 minutes to my house to hook it up and see how to work everything...and water is pouring out of the bottom of the hot heater and the pump is spewing water out all over! I am not a plumber, so I was not sure what to do, I called around and no one was willing to look at it because it was not in a home and it was not technically a motor home. I felt defeated, but I had a friend whose husband is a plumber, he looked at it. But he did not have the correct tools to work on the type of piping that was in there. Then my brother again came to my rescue, I called him upset and told him I would be getting his truck back ASAP but there was a problem with the trailer. He reminded me that his best friend and he buy houses and fix them up, and use that kind of piping! They were able to get it up and running. But this was how the first year went, something would get fixed, and another thing would break. Luckily, I have an amazing younger brother, husband, and neighbor who are all willing to come over and help with the repairs.

I have been reaching out to different churches around the Anchorage area to set up the trailer at their location and offer showers, but I have not gotten much response and was feeling discouraged. But then Anchor Park UMC's church council voted that I can use the showers in the church during the winter to offer free showers, which is amazing as the shower trailer is not winterized to run year-round. But there was no response from other area churches in 2021.

In June 2020 there was a big upheaval in the unhoused community in Anchorage, during COVID-19 one of the event arenas that is owned by the city had been used as a safe indoor space to house the unhoused. But at the end of June, it was closed, there was not a plan in place for where the over 200 individuals were to relocate. The mayor decided to open the campground at the edge of town and allow people to camp and waive the cost, so almost 200 people were moved into the neighborhood where I live. This included families of young children, adults, teenagers, those who are differently abled, etc. all moved into a campground that has been neglected since the 1970s There were no plans for meals, shelters, case management, or any services at all. This space is far from any other services that anyone could need, the closest grocery store is about a mile and a half away.

The Anchorage Coalition to End Homeless called an emergency meeting of the church which had been part of the Emergency Cold Weather Shelters to set up a few locations for weekly lunch distributions. I volunteered at the church I work at and also volunteered to bring the shower trailer to other locations to offer people showers. Twice a week I have been located at a church near a greenbelt, from 11 am-2 pm we have

had showers and free lunch for anvone who wants to participate. Each week there has been new people come over and say they heard they could take a shower and were excited the water was hot, and there were fresh clean towels. There have been individuals that come each time I am there and are so excited to take a shower. We have averaged about 10-15 showers per day, there is no time limit so some people take longer than others, but they all appreciate having the opportunity. Just think of how you feel after taking a shower when you haven't had a shower in a day or so...

The current supplies I have available are a combination of donations and what I have found on sale. The soap, shampoo, conditioner, and mouthwash were donated by a company that sells to the hotels, they had a shipment where the boxes were damaged and they couldn't see it. The towels are a combination of me finding a great deal at a second-hand store and church donations. Toothbrushes and toothpaste were donated by another individual. I wash the laundry at a laundromat once a week. The

biggest cost is gray water disposal and gas. I have been paying to have the water picked up daily because the trailer is not designed to be hauled with water in it, so after

each day I have a company that comes and pumps the water. The trailer is now stored at Birchwood Camp which is 15 miles from my house, which is 1/2 the distance it was before, so it's closer.

I have started a **Go Fund Me** account to help pay for water disposal and gas for my brother's truck, one day I will buy my own. My long-term goal is to make this a full-time job being a non-profit and to build a few of my own self-contained shower vans/ buses that have tank heaters and are designed specifically for Alaska's weather. I know this is not the biggest solution to how we are to solve the problem of helping those who are unhoused, but this is something I can do. Because at the end of the day, a shower, clean socks, etc. can brighten up someone's day. And that small thing shows that we see you and we care

about you. And isn't that what Jesus told us to do?

THE 1869 SOCIETY FREQUENTLY ASKED QUESTIONS

What exactly is the 1869 Society?

In the Spring of 2018, United Methodist Women, now United Women in Faith established the 1869 Society to thank and honor individuals who have named United Methodist Women's or United Women in Faith's Legacy Endowment Fund as a beneficiary of their will, trust, retirement plan, or life insurance policy. We decided upon the name "1869 Society" since it was the year of our founding. Those individuals who remember The Legacy Endowment Fund through a planned gift demonstrate a particularly thoughtful and generous way to connect their personal legacy with our organization's future.

Why did you establish the 1869 Society?

For many years, United Methodist Women has been remembered in people's wills and estate plans. And we have benefitted from this generous support. 


SEPARATED BY THE BORDER, DETAINED AND DEPORTED

These two books were two of the first I read this year. Frankly, I don't remember if I read them before or soon after becoming aware of the work Deaconess Cindy Johnson has and continues to do at the Texas border. *Detained and Deported* was



written by the same author as Death of Josseline, a book many of us read several years ago. Both books were hard to read, as a mother, almost unbearable. Separated by the Border is the story of a birth mother, a foster mother, and a migrant child's 3000mile journey from Honduras to the U.S. She was separated from her mother, who was held hostage by smugglers who exploited her physically and financially. The child came through the processing center as an unaccompanied minor. I won't write more about it, as we are all pretty aware of what it was like at the U.S. border, how children were separated from their parents, and as

far as I know, some still are. *Detained* and *Deported* tells the story of families under fire, those who have been here in the U.S. in some cases for years, working, attending school, marrying, and having families. The author demonstrates the ways that



draconian detention and deportation policies have broadened police powers, and enriched the private prison industry, through the most passive detention and deportation system we've ever had in the U.S.

Now our news channels are focusing on the Ukraine crisis and we aren't hearing much about the families, women, and children who are attempting to escape with the hope of a better and safer life. Please read these books, if you haven't already.

FAITH, HOPE, LOVE IN ACTION

"PACIFIC NORTHWEST CONFERENCE QUILTING PROGRAM"

Thirty-plus years ago Vera Zimmerman, past Pacific Northwest Conference United Methodist Women President, received a call from a pastor describing a quilt project for AIDS babies. He suggested United Methodist Women might make quilts for the Californiabased non-profit. Vera wrote in her March 1999 article that it made little sense to her to send quilts to California when there were many needs in Washington and Idaho. The in-Conference project that would supply quilts for small children and babies at risk was affirmed by the Pacific Northwest Conference United Methodist Women Executive Committee in April 1991. The process would be that each District would research groups and agencies in their District of the Conference that serve such children and babies

and who would be willing to gift the quilts to them. They would then be distributed by the districts. The project would emphasize the Campaign for Children. The goal: gifts of compassion and unconditional love and also a better understanding of the problems facing such children.

In the fall of 1991, quilts were displayed at District and Conference meetings. 143 quilts were brought to and displayed at the June 1992 United Methodist Church Annual Conference at the University of Puget Sound. Lois wrote, "Bishop McConnell said that the 1992 Conference session had been gentler, in greater harmony and showed more goodwill than usual." Each subsequent year quilts have been displayed at Annual Conference. As COVID-19 dictated virtual Annual Conferences in 2020,

'21, and '22 quilts were still made and distributed by Local Units to places in their communities serving at-risk young children and babies. Some Units have made hundreds. Lois wrote in an article back in March 1993 that she thought over 2,000 quilts had been made and gifted.

Today the need continues as does this project. Let's keep on quilting and plan to share warmth, our prayers, and our love for children and babies at risk in our communities wherever the need exists. We hope that one year these quilts may again be displayed at Annual Conference for all to see before they reach little ones in need. Our Faith, Hope, and Love will surely be known by this Action.




